Early Care and Education Panel and Roundtable Recommendations

1. Continue to build connections between Licensing, Certification, Youngstar, Wisconsin Shares and the Child and Adult Care Food Program (CACFP) Sponsors Forum.
2. Increase participation in regulated childcare by targeting outreach to unregulated family childcare.
3. Support, recommend, and refer appropriate clients to each other's programs and agencies.
4. Refer Family Day Care Home (FDCH) providers to the [CACFP Sponsors Forum website](#) to find a sponsor in their area.
5. Find the resources available to track trends in the child care field.
6. Use research that substantiates the CACFP as an indicator of quality child care to support the goals of increasing integrity and quality in the child care industry.
7. Establish a group to evaluate the most appropriate way to include input from the CACFP Sponsors Forum in the Youngstar rating system, determining if simply complying with regulation deserves a point or if a point is earned for actually participating in CACFP.
8. Establish a group to identify the barriers to participate in regulated childcare from a child care provider's perspective.
9. Develop and provide training and outreach for:
 - Persons who interact with Early Childhood Caregivers to provide the same message in response to Frequently Asked Questions, program goals and shared resources.
 - Parents by supporting Youngstar's outreach efforts to ensure the definition of quality child care includes participating in the CACFP.
 - Create networking opportunities between those interested in Early Care and Education.

Wellness: Obesity Prevention and Food Insecurity Panel and Roundtable Recommendations

- Continue our efforts to support and encourage CACFP participation and promote best practices in nutrition and physical activity amongst programs.
- Stay current with the proposed CACFP meal pattern changes
- Connect healthy eating and physical activity to overall wellness
- Promote the other United States Department of Agriculture (USDA) programs CACFP, Women's Infants and Children (WIC), Summer Food Service Program (SFSP), elderly nutrition programs, Supplemental Nutrition Assistance Program (SNAP), Emergency Food Assistance Program (TEFAP), National School Lunch and Breakfast Programs and the Special Milk Program.
- Support Wisconsin Early Childhood Obesity Prevention Initiative (WECOPI), UW Extension Family Living Programs and local food bank efforts.
- Recommend and share resources available from each organization and agency.
